# **Our Special Educational Needs Register (SEN)**

Total: 13 pupils

The 13 number and distribution of children currently on our SEN register is as follows:

### National data 2021/22 ALL SEN

The most common type of need among pupils with an EHC plan is autistic spectrum disorder (ASD)

Almost one in three pupils with an EHC plan are identified with a primary need of ASD (103,400 pupils).

The most common type of need among pupils with SEN support are speech, language and communication needs

The primary need identified for 262,400 pupils was speech, language and communication needs. This is followed by social, emotional and mental health needs (208,900 pupils) and moderate learning difficulty (197,400 pupils).

### **Exclusions (Fixed term) This Academic Year to Date:**

There have been no exclusions this academic year.

### **EHCP (Education Health Care Plan) Pupils.**

There are currently two pupils with EHC plans. Both children are in key stage 2. There is an additional KS2 EHCP is progress.

Information for Governors: In addition to the 'three' existing EHCPs a further statutory assessment request will be made for a year 1 pupil. A new EYFS pupil has joined the school this term, requiring high needs funding and a potential EHCP. Furthermore, a child with complex needs who is already supported by the specialist teaching service will be joining the school in September's YR cohort. This pupil has an EHCP in progress. Therefore, next academic year, the school could potentially have five pupils with EHCP plans which at 5.2% is above the National average (2.3% state funded primary schools).

### **SEN Pupils Targets and Review.**

Pupils on the SEN register have targets tailored to their individual needs which are recorded on class Provision Maps. Some pupils have will EHC plans or Personalised Provision Plans instead as their needs are greater/more complex. All targets are reviewed 3 times a year.

## Satisfaction Survey of Parents at Annual review of EHCP

There haven't been any annual reviews yet this academic year.

### **High Needs Funding (HNF)**

We currently have five pupils who receive High Needs Funding.

This has enabled us to provide on-going 1:1 and small group support for these pupils. Four pupils in receipt of high needs funding are in key stage 2 and the remaining child is in key stage 1.

### **Pupil Progress Tracking**

We continue to have pupil progress review meetings with class teachers, SLT and SENCDo 3 times a year. In addition, as a team, we have been focusing on key children who are below expected level, not making expected progress or could make accelerated progress. We endeavour to agree a practical approach to support these children through additional support within the classroom being mindful of a key focus area or additional interventions, stated on the class provision map.
